

TERMS AND CONDITIONS THE CHINA CLUB (SINGAPORE) SHINJI BY KANESAKA (SINGAPORE) CUT BY WOLFGANG PUCK (SINGAPORE) AMUZ GOURMET RESTAUARANT (JAKARTA) CASSIS FRENCH RESTAURANT (JAKARTA) SHOOK! (SHANGHAI)

- 1. This privilege is offered to all UOB Private Bank clients of United Overseas Bank Limited ("UOB") who maintain a minimum asset under management of S\$2 million with UOB ("Clients").
- 2. Each Client is entitled to one (1) of the following complimentary set meals (lunch or dinner) for two (2) persons at the respective participating restaurants

 - Shinji by Kanesaka (Raffles Hotel) Omakase Menu

 - Shook! (Shanghai) Customised Set Menu
- 3. The complimentary set meal can only be utilized in the Client's birthday month in 2014. Reservations for the complimentary set meal must be made at least 2 weeks in advance. Any reservation or complimentary set meal not made or utilized by the stipulated dates above will be forfeited. No payment or compensation whether in cash, credit or in kind shall be made for any forfeited, expired or unutilized reservation or complimentary set meal. All reservations must be made in the name of the Client. The Client must utilise the complimentary set meal on the reserved date and be present on the reserved date for the complimentary set meal.
- 4. Clients shall make their bookings and confirmation of all bookings through the Reserve Concierge at 1800 881 8886 in Singapore or +65 6881 8886 from overseas.
- 5. Reservation(s) for the complimentary set meal is subject to the relevant participating restaurant's availability at the time of booking and applicable black-out dates which will be advised during reservation.
- 6. The complimentary set meal and the preferential price (where applicable and only offered to additional guests on the reserved date) is not available at any other date/time even if the reservation is made through the UOB Private Bank Concierge.
- 7. This privilege is not transferable, exchangeable for cash or other items and cannot be used in conjunction with any other discounts, privileges, promotions or vouchers unless otherwise stated.
- 8. The participating restaurant reserves the right the change any part of the menu due to availability of ingredients.
- 9. Client is permitted to re-schedule any reservation which has been confirmed / amend his choice of the participating restaurant subject to availability at the respective participating restaurant and provided always that such re-scheduling / amendment is done at least (2) two weeks prior to the initial reserved date.



- 10. If the Client cancels any of the complimentary set meals or does not turn up on the reserved date, or make amendments to the reserved dates for the complimentary set meal; then the Client shall be subject to the individual participating restaurant's conditions for cancellation, amendment and no show, and the Client will be responsible for any charges / fees imposed in relation thereto. The complimentary set meal shall not be replaced or compensated in the event of cancellation and no-show.
- 11. The Client must maintain the minimum asset under management of S\$2 million at the point of booking and the utilization of the complimentary set meal, failing which UOB reserves the right to debit the cost of the complimentary set meal from the Client's accounts with UOB. Without limiting the generality of the foregoing, if UOB subsequently discovers that the Client is not eligible for this privilege, UOB may at its discretion (i) forfeit the booking for the complimentary set meal or (ii) if the complimentary set meal is already utilized, reclaim or debit the same or an amount equal to the costs of the set meal from the Client's accounts with UOB, without payment or compensation whatsoever or without giving any reason to such Client.
- 12. Client can order additional items or make reservations for additional persons, subject to the restaurant's availability, and provided that the costs of the additional items and additional persons are borne by the Client and paid directly to the relevant participating restaurant. Such additional costs are based on the restaurant's prices, and subject to service charge and prevailing government taxes.
- 13. For the avoidance of doubt, each Client shall be liable to pay for all his/her own costs, charges and expenses (including but not limited to, costs and expenses incurred for transportation, additional meals etc) and that of his/her guests incurred, sustained or suffered during their trip to and from the relevant participating restaurant and their stay at that restaurant. UOB shall not be liable or responsible to any party for the payment of the foregoing.
- 14. Each Client shall be personally responsible for his/her personal safety and the safety of his/her guests at all times within and in the restaurant. UOB shall not be liable for any loss, injury to or expenses, claim or damages of any Client or his/her guests or any other person incurred in connection with this privilege or utilization of the complimentary set meals.
- 15. UOB assumes no liability or responsibility for the acts or defaults of the merchant / participating restaurant or defects in the goods and services offered in this privilege. UOB is not an agent of the merchant / participating restaurant. Any dispute about the quality or service standard must be resolved directly with the merchant / participating restaurant. The merchant / participating restaurant may impose conditions for the redemption of the goods or services or utilization of the complimentary meals. UOB will not be responsible for any injury, loss or damage suffered as a result of the redemption or usage of the goods and services or utilization of the complimentary set meals.
- 16. UOB and the participating restaurants / merchants reserve the right to vary/amend the privileges and/or the terms and conditions at their discretion without prior notice. In a case of a dispute, the decision of UOB on all matters shall be final and no correspondence will be entertained.
- 17. The Client shall permit and authorise UOB to disclose, reveal and divulge his/her information and his/her guest's information and particulars to any person (including, without limitation, the parties involved in organizing this privilege, booking the reservation for the complimentary set meal) as UOB deems fit at its discretion for the purposes of this privilege (including any promotional, marketing, publicity purposes in connection thereto).
- 18. While the information provided herein is believed to be reliable as at the date of printing, UOB makes no representation or warranty whether express or implied, and accepts no responsibility or liability for its completeness or accuracy.



- 19. Participation in this privilege is subject to the terms and conditions herein.
- 20. A person who is not a party to these Terms and Conditions has no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) of Singapore to enforce or enjoy the benefit of any term herein.
