

**TERMS AND CONDITIONS
BVLGARI HOTELS AND RESORTS, BALI
BVLGARI HOTELS AND RESORTS, LONDON
BVLGARI HOTELS AND RESORTS, MILAN**

1. This privilege is offered to all Private Bank clients of United Overseas Bank Limited (“UOB”) who maintain a minimum asset under management of S\$2 million with UOB (“Clients”).
2. Each Client is entitled to one (1) complimentary night’s stay for two (2) persons at the Client’s choice one of the following properties (“Resorts”), subject to the terms and conditions herein
 - Bulgari Hotels and Resorts, Bali – Ocean View Villa
 - Bulgari Hotels and Resorts, London – Executive Double
 - Bulgari Hotels and Resorts, Milan – Special Room
3. Each complimentary night’s stay is inclusive of daily breakfast for two (2) persons and standard welcome and turndown gifts.
4. Reservations for the complimentary night’s stay must be made by 31 December 2014 and the complimentary night’s stay must be utilized by 31 March 2015. Each Client can only make a maximum of one (1) reservation for one (1) complimentary night’s stay. Any reservation or complimentary night’s stay not made or utilized by the aforesaid dates will be forfeited. No payment or compensation whether in cash, credit or kind shall be made for any forfeited, expired or unutilized reservation or complimentary night’s stay.
5. Each Client can book additional night(s) stay or for additional persons, subject to the Resorts’ availability, and provided that the costs of the additional nights’ stay and the additional persons are borne by the Client. Such additional costs will be based on the Resorts’ Best Available Rate on the day of booking and the payments for such additional costs shall be directly made by the Client using a UOB credit card or cash upon check-out. Such additional costs are also subject to service charge and prevailing government taxes.
6. The Client must maintain the minimum asset under management of S\$2 million at the point of booking and until his/her stay at the Resorts, failing which UOB reserves the right to debit the cost of the complimentary night stay from the Client’s account with UOB. Without limiting the generality of the foregoing, if UOB subsequently discovers that the Client is not eligible for this privilege, UOB may at its discretion (i) forfeit the reservation or the complimentary night’s stay; or (ii), if the complimentary night’s stay is already utilized, reclaim it or debit the same or an amount equal to the cost of the stay from the Client’s accounts with UOB, without payment or compensation whatsoever or without giving any reason to such Client.
7. Clients shall make their bookings for the complimentary night’s stay and confirmation of the same through the Private Bank Concierge at 1800 881 8886 in Singapore or +65 6881 6888 from overseas.
8. Reservations for the complimentary night’s stay must be made in the name of the Client and must be guaranteed by a UOB credit card. The Client must be present at the point of check-in to enjoy the complimentary night’s stay.
9. Reservation (s) for the complimentary night’s stay is subject to the Resorts’ room availability at the time of booking and the applicable black-out dates which will be advised during reservation.

10. The privilege offered herein is not transferable, exchangeable for cash or other it&ems and cannot be used in conjunction with any other discounts, privileges, promotions or vouchers unless otherwise stated.

11. If the Client cancels any of the complimentary night's stay or does not turn up on the reserved date, or make amendments to the reserved dates for the complimentary night's stay; then the Client shall be subject to the individual participating Resort's conditions for cancellation, amendment and no show, and the Client will be responsible for any charges / fees imposed in relation thereto. In the event of cancellation and no-show, the complimentary night stay will not be replaced or compensated.

12. Each Client shall be responsible for and liable to pay for all his/her own costs, charges and expenses (including but not limited to, costs and expenses incurred for transportation, additional meals etc) and that of his/her guests which are incurred, sustained or suffered during his/her or his/her guests trip to and from and during their stay at the Resort of choice. UOB shall not be liable or responsible to any party for the payment of the foregoing.

13. Each Client shall be personally responsible for his/her personal safety and the safety of his/her guests at all times within and in each participating resort. UOB shall not be liable for any loss, injury to or expenses, claim or damages of any Client or his/her guests or any other person incurred in connection with this privilege or utilization of the complimentary night's stay.

14. No pets are allowed in the Resorts.

15. UOB assumes no liability or responsibility for the acts or defaults of the participating merchant / Resorts or defects in the goods and services offered under this privilege. UOB is not an agent of the participating merchant / Resorts. Any dispute about the quality or service standard must be resolved directly with the participating merchant / Resorts. The participating merchant / Resorts may impose conditions for the redemption of the goods or services or utilization of the complimentary night's stay. UOB will not be responsible for any injury, loss or damage suffered as a result of the redemption or usage of the goods and services or utilization of the complimentary night's stay.

16. UOB and the participating Resorts / merchants reserve the right to vary/amend the privileges and/or the applicable terms and conditions without prior notice and at their discretion. In a case of a dispute, the decision of UOB on all matters shall be final and no correspondence will be entertained.

17. The Client shall permit and authorise UOB to disclose, reveal and divulge his/her information and his/her guest's information and particulars to any person (including, without limitation, the parties involved in organising, booking the stay) as UOB deems fit at its discretion for the purposes of this privilege (including any promotional, marketing, publicity purposes in connection thereto)..

18. Participation in this privilege is subject to the terms and conditions herein.

20. A person who is not a party to these Terms and Conditions has no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) of Singapore to enforce or enjoy the benefit of any term herein.

21. These terms and conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore, and all Clients who participate in this privilege shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
