

UOB VISA Electron Fortnightly Draws

Terms And Conditions

1. Eligibility

- 1.1. All UOB VISA Electron Card (the 'Card') members in good standing at the time of the Draws are eligible to participate.
- 1.2. All employees of the United Overseas Bank Group ('the Bank') and Singapore Press Holdings Group and their immediate families (i.e., spouses, parents and children) are not eligible to participate regardless whether the savings or current accounts held by such persons are maintained in single or joint names.

2. Dates And Drawing

- 2.1. There will be five fortnightly Draws as follows:

- 2.2. One chance is given for every single receipt of a minimum S\$50 paid using the Card from 8 March to 9 May 2001.
- 2.3. Chances earned are accumulated and are eligible for all subsequent draws in the series (The last Draw is on 11 May 2001).
- 2.4. Only one winner will be declared in each Fortnightly Draw and he/she shall receive a cash prize equivalent to 20 times the amount on his/her winning receipt, subject to a maximum of S\$2,000.
- 2.5. A Card member who has won a prize in one Draw is still eligible to participate in subsequent Draws.
- 2.6. A Card member can participate in the Fortnightly Draws by calling the UOB VISA Electron Hotline and keying in his/her Card number, the receipt number, transaction amount and date of transaction. Each receipt of a minimum of S\$50 is entitled to one Draw chance. All duplicate entries will be disqualified.

- 2.7. Each qualifying receipt will be assigned an entry form bearing a serial number and deposited by Singapore Press Holdings into a lucky draw box. During each Fortnightly Draw, one winning entry will be randomly selected by hand from the lucky draw box by an employee of the Bank under the supervision of their internal auditors and witnesses from the Singapore Press Holdings Group. The Draws will be held in public at Singapore Press Holdings, 82 Genting Lane, News Centre, Singapore 3459567 at 3.00 pm.
- 2.8. At each Fortnightly Draw, the Bank reserves the right to draw reserve winning chances to replace any winner(s) subsequently found to be disqualified for any reason whatsoever.
- 2.9. A winner will be disqualified if his/her account(s) is not in good standing and/or if his/her Card is cancelled, either by the customer or the Bank, at any time before the Draw dates.

3. Prizes

- 3.1. Prizes cannot be transferred to another person. All cash prizes will be credited into the winner's savings or current account that is linked to his/her Card.
- 3.2. All winners will be notified by post and/or telephone.
- 3.3. The Bank reserves the right to use the names and pictures/photographs of the winners for advertisements or other promotions or otherwise engage the winners in any publicity on the Draws.
- 3.4. The Bank reserves the right to use any information provided by any participant for any future marketing efforts.

4. Decisions Of The Bank

- 4.1. The Bank reserves the right to withdraw these Draws or amend these terms and conditions at any time at its sole and absolute discretion, without prior notice to any party.
